I also agree to pay in advance a security/cleaning deposit in the amount of \$125. The deposit is to cover damage to the property by other than normal wear or tear or if the property is not used in accordance with the conditions listed below. The deposit may be refunded upon completion of inspection to be completed by the appointed Veteran Hall Sponsor and all noted discrepancies corrected. I agree the donation fee is \$50 per use for active contributing Post/Auxiliary members, \$125 per day for first responders use and \$300 per day for non-active members and other organizations.

## CONDITIONS REQUIRED FOR RENTAL

### Failure to comply can result in loss of Security Deposit

1. Use of the Veterans Hall is restricted to paid up members of either post.
2. No alcoholic beverages, drugs, firearms or explosives allowed on Veteran owned property.
3. Smoking is not permitted in the Veterans Hall.
4. No cooking within the Veterans Hall.
5. All furniture and fixtures will be returned to their original positions.
6. All garbage will be removed. A dumpster is available outside the building.
7. Floors, Kitchen, restrooms and any other part of the building used will be cleaned.
8. No decorations can be hung from the ceiling.
9. Application must be signed, the Donation and Security Deposit paid prior to use.
10. Set the thermostats to 75 degrees in the summer and 65 in the winter.
11. Secure all doors prior to exiting.

I, as the **USER**, agree not to hold the Veterans organizations responsible in case of injuries to myself or to any guests or for any loss of personal property that may occur on the property/premises owned by the Veterans organizations and will indemnify and hold such Veterans organizations, including members and officers, harmless on account of all such claims for personal injury or property loss. I also agree that I will reimburse the Veterans Hall for any damage or cleaning costs in excess of the security/cleaning deposit.

I, as a **SPONSOR**, agree to: serve as the primary point of contract for this event; coordinate with the USER to understand the intended use; explain the above conditions and collect the donation fee and deposit; be available to support the USER during the event; then inspect the Hall to ensure it has been cleaned and restored to before-use condition.
